

## Foundation Bubble Closure

Dear Parent or Carer,

We have been informed today of a positive Lateral Flow Test for coronavirus (COVID-19). These tests are not conclusive and need to be followed up by a <u>full PCR test</u>. On discussion with the DFE Coronavirus helpline we have been informed that we need to send pupils home and ask them to isolate. Unlike in Secondary Schools the advice for Early Years is that **all pupils and staff** should be regarded as a contact due to difficulties with social distancing at that age.

On this basis we have followed their national guidance and considered the risk assessment with Public Health England (PHE) advisers. This has identified that **all Foundation Pupils** are counted as close contacts with the individual who has had a positive test result for coronavirus (COVID-19) and your child must stay at home and self-isolate up to and including 2<sup>nd</sup> April. This means they are not to return to school until after the Easter break on the 19<sup>th</sup> April.

Work and activities will be provided on Seesaw and Tapestry by the Foundation Staff Team from tomorrow.

If the result of the PCR test is negative all children can return to school the next day.

Other members of your household can continue normal activities, provided your child does not develop symptoms within the 10 day self-isolation period including siblings who can attend school.

## What to do if your child develops symptoms of coronavirus (COVID 19)

Having been identified as a close contact, if your child then develops symptoms of coronavirus (COVID-19), they should remain at home for at least 10 days from the date when their symptoms appeared. Symptoms of coronavirus (COVID-19) are a new, continuous cough, or a high temperature, or a loss of, or change in, their normal sense of taste or smell (anosmia). Anyone with symptoms will be eligible for a PCR test - this is the type of test that is normally available and can be arranged via <a href="https://www.nhs.uk/ask-for-a-coronavirus-test">https://www.nhs.uk/ask-for-a-coronavirus-test</a> or by calling 119.

People who do not have symptoms or have not tested positive using a Lateral Flow Device should not request a PCR test unless this has been specifically requested by Public Health England or the local authority.

All other household members who remain well must stay at home and not leave the house for 10 days. This includes anyone in your 'Support Bubble'.

The household isolation period includes the day the first person in your household's symptoms started (or the day their test was taken if they did not have symptoms) and the next 10 full days. This means that if, for example, your 10 day isolation period starts on the 15th of the month, your isolation period ends at 23:59 hrs on the 25th and you can return to your normal routine.

Household members should not go to work, school or public areas, and exercise should be taken within the home. If you require help with buying groceries, other shopping or picking up medication, or walking a dog,

you should ask friends or family. Alternatively, you can order your shopping online and medication by phone or online.

Household members staying at home for 10 days will greatly reduce the overall amount of infection the household could pass on to others in the community.

If you are able, move any vulnerable individuals (such as the elderly and those with underlying health conditions) out of your home, to stay with friends or family for the duration of the home isolation period. If that is not possible, anyone with symptoms should try and stay as far away as possible from vulnerable members of your household.

### How to stop coronavirus (COVID-19) spreading

There are things you can do to help reduce the risk of you and anyone you live with getting ill with coronavirus (COVID-19):

- wash your hands with soap and water often do this for at least 20 seconds
- use hand sanitiser gel if soap and water are not available
- wash your hands as soon as you get home
- cover your mouth and nose with a tissue or your sleeve (not your hands) when you cough or sneeze
- put used tissues in the bin immediately and wash your hands afterwards
